Legal Action Chicago seeks justice for people living in poverty. Through litigation, advocacy, and organizing, our legal team fights to improve policies and systems that secure rights to affordable housing, basic healthcare, fair working conditions, protection from abuse, and economic stability.

Recently, for example, Legal Action Chicago:

- Won a federal court ruling holding Cook County liable for unconstitutionally confiscating home equity from homeowners who lost their homes for failing to pay property taxes, when the market value of the homes was higher than the tax debt. Over 2,000 former homeowners, mostly older or medically frail, will recover their lost equity.
- In a string of Illinois Commerce Commission cases, improved “affordability” by helping to win meaningful discounts for low-income customers on the rates they pay for gas, electricity and water.
- Annually leads efforts that pass legislative improvements to various systems and policies involving, among others, domestic violence, ownership of property, debt prevention and debt collection, and protection from unlawful immigration arrests.

To ensure that low-income communities have an advocate in their corner, Legal Action Chicago relies on private donations.
